PARAGON ENTERTAINMENT HOLDINGS, LLC'S "WIN A YEAR OF FREE POPCORN" SWEEPSTAKES

No Purchase or Payment of Any Kind is Necessary to Enter or Win This Sweepstakes

The **PARAGON ENTERTAINMENT HOLDINGS, LLC'S "WIN A YEAR OF FREE POPCORN" SWEEPSTAKES** ("Sweepstakes") is sponsored by PARAGON THEATERS ("Sponsor"). The Sweepstakes begins Thursday, January 19, 2023 and ends Tuesday, January 31, 2023.

1. **ELIGIBILITY:** Open only to legal United States residents, 18 years of age or older. Employees, officers, directors, agents, representatives, and the immediate family members of Sponsor, and their parent companies, affiliates, subsidiaries, advertising, promotional agencies and promotional partners (collectively "Sweepstakes Entities") are ineligible to enter or win the Sweepstakes. A driver's license, or state issued ID, or another photo ID is required when pass is presented. This Annual Popcorn Pass is not refundable, not redeemable or exchangeable for cash.
