PARAGON THEATERS THE BATMAN ULTIMATE FREE SCREENING SWEEPSTAKES **No Purchase or Payment of Any Kind is Necessary to Enter or Win This Sweepstakes**

The **PARAGON THEATERS THE BATMAN ULTIMATE FREE SCREENING SWEEPSTAKES** ("Sweepstakes") is sponsored by PARAGON THEATERS ("Sponsor"). The Sweepstakes begins Friday, March 11th, 2022 and ends Thursday, March 24th, 2022.

1. **ELIGIBILITY:** Open only to legal United States residents, 18 years of age or older. Employees, officers, directors, agents, representatives, and the immediate family members of Sponsor, Warner Bros. Ent. and their parent companies, affiliates, subsidiaries, advertising, promotion agencies and promotion partners (collectively "Sweepstakes Entities") are ineligible to enter or win the Contest. This Sweepstakes is void where prohibited by law. All federal, state and local laws and regulations apply. 2. **HOW TO ENTER:** Use your Facebook or Instagram account to access Sponsor's Facebook page (<https://www.facebook.com/ParagonTheaters>) or Instagram page (https://www.instagram.com/paragon_theaters/) during the Promotion Period, locate *The Batman Ultimate Free Screening Sweepstakes* post and follow the on-screen instructions. The authorized account holder of the Facebook or Instagram account will be deemed the entrant and will receive one (1) entry into the Sweepstakes, subject to the eligibility restrictions below. An "authorized account holder" is the natural person assigned the e-mail address used to create the social media account used to enter the Sweepstakes. There is a limit of one entry per person per day. To be eligible, all entries for Sweepstakes must be received by 11:59 p.m. (Eastern Time) on March 24th, 2022, the Sweepstakes Expiration Date. Entries that are late (including delayed data transmissions), forged, illegible, mutilated, incomplete, misdirected, or otherwise not in compliance with these Official Rules will be disqualified.

3. **SELECTION OF WINNER AND NOTIFICATION:** Winners will be selected randomly from among all sweepstakes entrants on or about March 29th, 2022. Sponsor's decisions are final in all respects. Odds of winning depend on the number of eligible entries received. Winner will be notified by e-mail or phone on/about March 30th, 2022. If a potential winner cannot be reached after a reasonable effort has been exerted during three (3) days from the date of the Sweepstakes drawing, or if he/she is found to be ineligible, or if he/she cannot or does not comply with these Official Rules, an alternate winner may be selected. If winner is a minor in his/her state of residence, prize will be awarded in the name of winner's parent/legal guardian.

4. **DESCRIPTION OF PRIZE AND ARV:** (1) Grand Prize Winner will be awarded a private screening of Warner Bros. THE BATMAN, for them plus (20) friends, at the Paragon Theaters location closest in proximity to their home. Restrictions may apply and the screening is subject to availability. Screening may only take place on a weekday (Monday through Thursday) during the theater's standard operating business hours. Limited concessions are included in the screening package and are subject to availability.

Total Approximate Retail Value ("ARV") of all prizes: (1) \$1,500 per screening event.
